



DO BIG STUDIOS BOUNTY TERMS & CONDITIONS

Last updated: February 15, 2026

The Do Big Studios' Bug Bounty Programs Terms and Conditions ("**Terms**") cover your participation in the Do Big Studios' Bug Bounty Program (the "**Program**"). These Terms are between you and Mobile Game Advertising & More, Inc. dba Do big Studios ("**Do Big**," "**us**" or "**we**"). By submitting any vulnerabilities to Do Big or otherwise participating in the Program in any manner, you accept these Terms.

OVERVIEW

The Program enables users to submit vulnerabilities and exploitation techniques ("**Vulnerabilities**") to Do Big about eligible Do Big products and services ("**Products**") for a chance to earn rewards in an amount determined by Do Big in its sole discretion ("**Bounty**"). The decisions made by Do Big regarding Bounties are final and binding. Do Big may change or cancel this Program at any time, for any reason.

ELIGIBILITY

You are eligible to participate in the Program if you are 14 years of age or older. If you are at least 14 years old but are considered a minor in your place of residence, you must obtain your parent's or legal guardian's permission prior to participating in this Program.

You are not eligible to participate in the Program if you meet any of the following criteria:

- You are a resident of any country under U.S. sanctions or any other country that does not allow participation in this type of program;
- You are under the age of 14;
- Your organization does not allow you to participate in these types of programs;
- You are currently, or within the six months prior to providing us your Submission, an employee, contractor, or have any contractual relationship with Do Big or a Do Big subsidiary;
- An immediate family (parent, sibling, spouse, or child) or household member is currently, or within the six months prior to providing us a Submission, was an employee, contractor, or have any contractual relationship with Do Big or a Do Big subsidiary;

Do Big prohibits any financial transactions with individuals or entities designated by certain trade laws or sanctions (including Iran, Cuba, Syria, North Korea, Russia, and Belarus).

Do Big reserves the right to disqualify any participant. Participation and the awarding of prizes are at Do Big's sole discretion and may be subject to additional eligibility criteria. If you have questions about these laws or regulations, please consult your own legal counsel.

SUBMISSION PROCESS

If you believe you have identified a Vulnerability, you may submit it to Do Big through the process described below:

Each Vulnerability submitted to Do Big shall be a “**Submission.**” Submissions must be submitted to security@dobig.com or use the web submission form. In the initial email, the subject of your email must be “Bug Bounty Submission,” and it must specify the Vulnerability details. Please also include as much of the following information as possible:

- Type of issue
- Product or URL
- Step-by-step instructions to reproduce the issue
- Proof-of-concept or exploit code
- Impact of the issue, including how an attacker could exploit the issue

Depending on the detail of your Submission, Do Big may award a Bounty of varying scale. Well-written reports and functional exploits are more likely to result in Bounties. Those Submissions that do not meet the minimum bar described above are considered incomplete and not eligible for Bounties.

There are no restrictions on the number of qualified Submissions you can provide and potentially be paid a Bounty for.

If you submit a Vulnerability for a product or service that is not covered by the Program at the time you submitted it, you will not be eligible to receive Bounty payments if the product or service is later added to the Program.

CODE OF CONDUCT

By participating in the Program, you will follow these rules:

- Don't do anything illegal.
- Don't engage in any activity that exploits, harms, or threatens to harm children.
- Don't send spam. Spam is unwanted or unsolicited bulk email, postings, contact requests, SMS (text messages), or instant messages.
- Don't share inappropriate content or material (involving, for example, nudity, pornography, graphic violence, or criminal activity).
- Don't engage in activity that is false or misleading.
- Don't engage in activity that is harmful to you, the Program, or others (e.g., transmitting viruses, stalking, posting terrorist content, communicating hate speech, or advocating violence against others).
- Don't infringe upon the rights of others (e.g., unauthorized sharing of copyrighted material) or engage in activity that violates the privacy of others.
- Don't interact with an individual account (which includes modifying or accessing data from the account) without the account owner's explicit consent in writing, which you must produce upon request.
- Don't violate any platform Terms of Service (such as the Roblox Terms of Use).

- Don't exploit a Vulnerability you discover for any reason other than for testing purposes, and only do so on your own account, a test account, or another account for which you have the explicit written consent of the account owner to test.
- Don't harass or discriminate others, or use abusive language. This includes, but is not limited to, insults, threats, discriminatory comments, targeted profanity, and personal attacks (including "doxing").
- Don't send us aggressive or demanding messages regarding a Submission.
- Don't submit a large number of unverified, out of scope or otherwise non-qualifying Submissions.
- Don't repeatedly request updates or file duplicate Submissions.
- Don't threaten to withhold vulnerability details, sell the vulnerability to a third party, or disclose it publicly unless a Bounty is paid.
- Don't act in bad faith to fraudulently obtain a Bounty, including misrepresenting your identity, or submitting knowingly false Submissions.
- Don't help others break these rules.

If you violate these Terms, you may be prohibited from participating in the Program in the future and any Submissions you have provided may be deemed to be ineligible for Bounty payments.

SUBMISSION LICENSE

Do Big is not claiming any ownership rights to your Submission. However, by providing any Submission to Do Big, you:

- grant Do Big the following non-exclusive, irrevocable, perpetual, royalty free, worldwide, sub-licensable license to the intellectual property in your Submission: (i) to use, review, assess, test, and otherwise analyze your Submission; (ii) to reproduce, modify, distribute, display and perform publicly, and commercialize and create derivative works of your Submission and all its content, in whole or in part; and (iii) to feature your Submission and all of its content in connection with the marketing, sale, or promotion of this Program or other programs (including internal and external sales meetings, conference presentations, tradeshow, and screen shots of the Submission in press releases) in all media (now known or later developed);
- agree to sign any documentation that may be required for us or our designees to confirm the rights you granted above;
- understand and acknowledge that Do Big may have developed or commissioned materials similar or identical to your Submission, and you waive any claims you may have resulting from any similarities to your Submission;
- understand that you are not guaranteed any compensation or credit for use of your Submission; and
- represent and warrant that your Submission is your own work, that you haven't used information owned by another person or entity, and that you have the legal right to provide the Submission to Do Big.

RESTRICTIONS ON DISCLOSURE

We try to address each Vulnerability report in a timely manner. We require that Bounty Submissions remain confidential and cannot be disclosed to third parties. You can make available high-level descriptions of your research and non-reversible demonstrations after the Vulnerability is fixed. We require that details that would make attacks easier be withheld for 30 days after the Vulnerability is fixed. Do Big will notify you when the Vulnerability in your Submission is fixed. You may be paid prior to the fix being released and payment should not be taken as notification of fix completion. If you impose a fix timeline, you will forfeit your bounty eligibility. Violations of this section could require you to return any Bounties paid and disqualify you from participating in the Program in the future.

SUBMISSION REVIEW PROCESS

After a Submission is sent to Do Big in accordance with the above, Do Big will review the Submission and validate its eligibility. The review time will vary depending on the complexity and completeness of your Submission, as well as on the number of Submissions we receive.

Do Big retains sole discretion in determining which Submissions are qualified, according to the rules set forth herein. If we receive multiple bug reports for the same issue from different parties, the Bounty will be granted to the first eligible Submission. If a duplicate report provides new information that was previously unknown to Do Big, we may award a differential to the person submitting the duplicate report.

BOUNTY AMOUNTS

Bounties are awarded solely at Do Big's discretion and are not guaranteed. The following categories represent potential maximum award ranges only and do not create any obligation to award a Bounty in any specific amount:

- **Critical Severity** (e.g., remote code execution, server compromise, data exfiltration, item duplication, or systemic economy compromise): up to \$5,000.
- **High Severity** (e.g., significant gameplay manipulation, anti-cheat bypasses, privilege escalation, material economic imbalance): up to \$1,000
- **Medium Severity** (e.g., moderate exploit conditions, logic flaws, UI bypasses without material economic or security impact): up to \$500.

Actual Bounty amounts, if any, will be determined by Do Big in its sole and absolute discretion based on factors including, but not limited to:

- Severity and impact of the Vulnerability
- Quality and completeness of the Submission
- Reproducibility and exploitability
- Scope and affected user base
- Whether the issue was previously known
- Business impact and risk exposure

- Any violation of these Terms
- The existence of duplicate reports

Do Big reserves the right to:

- Award a Bounty in an amount lower than the stated maximum;
- Award no Bounty for a Submission;
- Reclassify the severity of any Submission;
- Modify bounty tiers or ranges at any time;
- Issue non-monetary recognition in lieu of payment;
- Aggregate related Submissions into a single award.

Nothing in this Program creates a contractual right to payment.

BOUNTY PAYMENTS

The decisions made by Do Big regarding Bounties are final and binding.

If we have determined that your Submission is eligible for a Bounty, we will notify you of the Bounty amount and provide you with the necessary paperwork to process your payment. You may waive the payment if you do not wish to receive a Bounty.

If there is a dispute as to who the qualified submitter is, we will consider the eligible submitter to be the authorized account holder of the email address used to enter the Program.

Before receiving a Bounty, you are required to complete and submit an Internal Revenue Service tax form (e.g., Form W-9) within 30 calendar days of notification of validation. If you do not complete the required forms as instructed or do not return the required forms within the time period listed on the notification message, we may not provide payment. We cannot process payment until you have completed and submitted the fully executed required documentation.

If your Submission qualifies for a Bounty, please note:

- you may not designate someone else as the Bounty recipient unless you are considered a minor in your place of residence;
- if you are eligible for this Program but are considered a minor in your place of residence, we may award the Bounty to your parent/legal guardian on your behalf and require them to sign all required forms on your behalf. The Bounty will be added to the taxable income of your parent/legal guardian;
- if you are unable or unwilling to accept your Bounty, we reserve the right to rescind it; and
- if you accept a Bounty, you will be solely responsible for all applicable taxes related to accepting the payment(s).

NO WARRANTIES

DO BIG AND OUR AFFILIATES MAKE NO WARRANTIES, EXPRESS OR IMPLIED, GUARANTEES OR CONDITIONS WITH RESPECT TO THE PROGRAM. YOU UNDERSTAND THAT YOUR PARTICIPATION IN THE PROGRAM IS AT YOUR OWN RISK. TO THE EXTENT PERMITTED UNDER YOUR LOCAL LAW, WE EXCLUDE ANY IMPLIED WARRANTIES IN CONNECTION WITH THE PROGRAM. YOU MAY HAVE CERTAIN RIGHTS UNDER YOUR LOCAL LAW. NOTHING IN THESE TERMS IS INTENDED TO AFFECT THOSE RIGHTS, IF THEY ARE APPLICABLE.

LIMITATION OF LIABILITY & BINDING ARBITRATION

If you have any basis for recovering damages in connection with the Program (including breach of these Terms), you agree that your exclusive remedy is to recover, from Do Big or any affiliates direct damages up to \$100.00. You can't recover any other damages or losses, including direct, consequential, lost profits, special, indirect, incidental, or punitive. These limitations and exclusions apply even if this remedy doesn't fully compensate you for any losses or fails of its essential purpose or if we knew or should have known about the possibility of the damages. To the maximum extent permitted by law, these limitations and exclusions apply to anything or any claims related to these Terms and the Program.

BINDING ARBITRATION AND CLASS ACTION WAIVER

You and we agree to binding individual arbitration before the Arbitration Services of Portland ("**ASP**") under the Federal Arbitration Act ("**FAA**"), and not to sue in court in front of a judge or jury. Instead, a neutral arbitrator will decide and the arbitrator's decision will be final except for a limited right of review under the FAA. Class action lawsuits, class-wide arbitrations, private attorney-general actions, and any other proceeding where someone acts in a representative capacity aren't allowed. Nor is combining individual proceedings without the consent of all parties. "**We,**" "**our,**" and "**us**" includes Do Big and Do Big's affiliates.

- Disputes Covered. The term "dispute" is as broad as it can be. It includes any claim or controversy between you and us concerning the Program or these Terms, under any legal theory including contract, warranty, tort, statute, or regulation.
- Procedure. The arbitration will be conducted by one arbitrator appointed in accordance with ASP rules, in person, in Portland, Oregon; provided, however that to the extent the ASP rules conflict with these Terms, these Terms will control. The arbitrator shall apply New York substantive law to the resolution of any dispute without reference to, or application of, New York's conflicts of law provisions or its statutory arbitration provisions. The existence of the arbitration proceeding, any information exchanged during the arbitration proceeding, and any arbitration award issued, shall be strictly confidential except to the extent specifically required for its recognition and enforcement. The arbitrator shall rule on their own jurisdiction, including any objections with respect to the existence, scope or validity of the arbitration agreement or the arbitrability of any claim or counterclaim.
- Must File Within One Year. You and we must file in an arbitration (except intellectual property disputes) within one year from when it first could be filed. Otherwise, it's permanently barred.

- Severability. If the class action waiver is found to be illegal or unenforceable as to all or some parts of a dispute, then those parts won't be arbitrated but will proceed in court, with the rest proceeding in arbitration. If any other provision of this section is found to be illegal or unenforceable, that provision will be severed but the rest of this section still applies.

MISCELLANEOUS

These Terms are the entire agreement between you and Do Big for your Participation in the Program. It supersedes any prior agreements between you and Do Big regarding your participation in the Program. All parts of these Terms apply to the maximum extent permitted by relevant law. If a court or arbitrator holds that we can't enforce a part of these Terms as written, we may replace those terms with similar terms to the extent enforceable under the relevant law, but the rest of these Terms won't change.

UNSOLICITED IDEAS

Other than your Submission, Do Big does not consider or accept unsolicited proposals or ideas, including without limitation ideas for new products, technologies, promotions, product names, product feedback and product improvements ("Unsolicited Feedback"). If you send any Unsolicited Feedback to Do Big through the Program or otherwise, Do Big makes no assurances that your ideas will be treated as confidential or proprietary.

CHANGES TO THESE TERMS

We may change these Terms at any time. Participating in the Program after the changes become effective means you agree to the new Terms. If you don't agree to the new Terms, you must not participate in the Program.

IF YOU DO NOT AGREE TO THESE TERMS, PLEASE DO NOT SEND US ANY SUBMISSIONS OR OTHERWISE PARTICIPATE IN THIS PROGRAM.
